1.TRUSTEES mean and include the Board of Trustees as described in these presents, and these Trustees, as appointed, nominated or selected by the remaining members of the Board of Trust whenever any vacancy arises.

2.CREATION OF THE TRUST:

In pursuance of the intention, the AUTHOR OF TRUST has settled the sum of Rs.1008/-(Rupees One Thousand Eight Only) by cash unto and in favour of the Trustees herein to be held by them for and on behalf of the Trust hereby created and known as "SIVASAKTHI EDUCATIONAL TRUST" the receipt of which sum of Rs.1008/-(Rupees One thousand Eight only) which has already been handed over to the Trustees mentioned hereunder which the Trustees shall hold together with all accumulations and accretions thereto by way of income there from, gifts, donations or otherwise and all other assets acquired by the trust, upon Trust for the aforesaid purposes.

3. REGISTERED OFFICE OF THE TRUST:

5.1. MOTTO OF THE TRUST:

The Motto of the Trust is to do charitable works more fully described hercunder.

5.2. OBJECTS OF THE TRUST:

The objects of the Trust are. -

(a) To establish, run, support, and grant aid or other financial assistance to schools, colleges, libraries, reading rooms, universities, laboratories, research and take over other institutions(functioning or defunct) of the like nature in India, for use of the students and the staff and also for the development and advancement of education and diffusion of knowledge to the needy persons.

- (b) To establish, develop, maintain and grant aid in cash or in kind to hospitals, schools, medical colleges, nursing institutions, dispensaries, maternity homes, child welfare centres and old age homes or such other similar charitable institutions in India for the benefit and use of the general public.
 - (c) To establish, maintain and run studentships, scholarships and render other kind of aid to students including supply of books, stipends, medals and other incentives to study, without any distinction as to caste colour, race, creed or sex.
 - (d) To promote, establish, support, maintain or grant aid to institutions for the promotion of science, literature, music, drama and fine arts, for the preservation of historical monuments and research and other institutions, in India, having similar objects for the benefit of the public in general
 - (e) To establish and maintain houses for stay of needy persons who are old and neglected by the society, destitute, handicapped, invalid or orphans, widowers and neglected women provide them food, clothing and medicines on nominal charges and also at free of cost.
 - (f) To distribute clothes, food articles, medicines and other day to day requirements to the needy persons and poor.
 - (g) To provide necessary relief to the needy such as education, medical relief and Advancement of other objects of general public utility.

- (h) To carry out such secular charities as the Board of Trustees may decide.
- (i) The Trust shall not carry any activity with a view to earn profit.
- (j) The activities of the Trust shall be confined only within India and no part of its activities shall be carried out outside the Indian Territories.
 - (k) This Declaration of Trust is irrevocable.
 - (I) To establish, develop, maintain and grant aid in cash or in kind to hospitals, schools, medical colleges, nursing institutions, dispensaries, maternity homes, child welfare centres and old age homes or such other similar charitable institutions in India for the benefit and use of the general public.
 - (m) establish, maintain or grant aid for the establishment and/or maintenance of parks, gardens, gymnasiums, sports clubs, dharmashnias and rest houses, for use by public in general.
 - (n) To establish, maintain or grant aid to homes for the aged, orphanages or other establishments for the relief and help to the poor, needy and destitute people, orphans, widows and aged persons.
 - (o) To establish and develop institutions for the physically handicapped and disabled or mentally retarded persons and to provide them education, food, clothing or other help.

(p) To grant relief and assistance to the needy victims during natural calamities such as famine, earth quake, flood, fire, pestilence, Tsunami etc. and to give donations and other assistance to institutions, establishments or persons engaged in such relief work.

(q) To grant aid, to take over or render assistance to other public charitable trusts or institutions with their subsisting and existing assets.

5.3.BENEFIT OF THE TRUST:

The Benefits of the Trust are open to all irrespective of Caste, religion, race, sex etc. That the Trust will not carry on any activities with an intention of earning profit.

6. THE PROPERTIES OF THE TRUST

The properties of the Trust shall be .-

(a) the said sum of Rs.1008/-above referred to the receipt of which is hereby acknowledged by the Trustees; Trust fund shall not be applied for any purpose other than those specified hereunder.

 (b) any properties movable or immovable, that may be acquired by the Trust either by purchase or otherwise;

(c) all additions and acceptations to the Trust fund;

(d) all voluntary donations both towards corpus or otherwise gifts,
 legacies or grants in cash or in kind accepted by the trustees;

(c) all grants and contributions made to the Trust by the Government, Government bodies, Trust or Institutions, Trade Union or Societies etc; and

(f) all sums and assets which by and means become the property of the Trust.

7. CESSATION OF TRUSTEESHIP:

A Trustee mentioned above shall cease to be the trustee of the Trust if:-

- (a) he/she resigns;
 - (b) he/she becomes insolvent;
 - (c) He/she is removed by the majority of the members of the trust, if it is found that the trustee(s) activities are detrimental to the activities or administration or funds of the Trust

8.APPOINTMENT OF TRUSTEES:

The Author of Trust shall be the Managing Trustee . Any vacancy in the Board of Trustees shall be filled up by the Managing Trustee in consultation with other Trustees.

9. ADMINISTRATION OF THE TRUST;

The administration of the TRUST shall vest with the Author of the Trust who will be the Managing Trustee of the Trust.

10. POWER OF THE TRUSTEES;

The Board of Trustees shall have the control and management of the Trust and exercise the following powers:

- a) To determine from time to time to commence and to take up the object and purposes for which the funds of the trust shall be used and allot and allocate to each of the objects such portion of the funds as they deem fit;
 - b) To purchase and acquire any immovable property of any kind for this object of the Trust or as a source of income for the Trust;
 - c) To incur all expenditure necessary as in their own opinion useful for carrying out the objects and administration of the trust:
 - d) To open one or more bank accounts of the trust with any bank or banks as the Trustees may deem fit and deposit monies of the Trust in the Bank accounts and authorize any of the Trustee/Trustees either singly or jointly to operate such Bank account.
 - e) to employ staff of all kinds necessary and useful for carrying out the objects of the trust.
 - f) To incur such other items of expenditure as is necessary and incidental for carrying out the objects of the Trust;
 - g) To institute, conduct, defend, compound, withdraw, compromise, adjust, refer to arbitration or to do such things as

are incidental and necessary, concerning the affairs of the Trust and to sign and verify vakalats, pleadings, affidavits and other powers'

- h) To accept contributions in cash or in kind either by way of addition to the trust funds generally or for any one or more of the specified objects of the Trust.
 - i) To establish as many adhoc committees for any purpose.

11. Meetings of the Trustees:

- a) The Managing Trustee shall preside over all the meetings of the trustees and in her absence the trustees attended such meeting may elect any one of them to preside over the meeting;
 - b) The meetings of the Trustees may be convened by the Managing Trustee or under her direction by any other Trustees
 - c) The quorum of the meeting of the Trustees shall be three personally present.
 - d) In the event of equality of votes, the person presiding such meeting shall exercise casting vote (additional vote).

12. RESOLUTIONS:

a) The Trustees may exercise all the powers vested in them in clause 10 under these presents by resolution passed at a simple

b) Any resolution in writing signed by all Trustees holding office for the time being shall be valid and binding.

13. SUITS:

The Managing Trustee of the Trust is authorized to sue or to be sued on behalf of the Trust.

14. Execution of Documents:

All Deeds, Documents etc. shall be executed by the Managing Trustee and any other trustee as directed by Managing Trustee in her absence.

15. ACCOUNTS AND AUDIT:

- a) The Trustees shall maintain true and correct accounts of all Trust monies and of all the income and investments and all the outgoing expenses.
 - b) The year of account shall be the financial year commencing from 1st APRIL and ending 31st March.

- The Trustees shall each year issue a report setting out the accounts showing the income and expenditure of the Trust for the preceding year not later than six months from the end of the preceding year of accounts.
- d) The accounts of the Trust shall be audited every year by a Chartered Accountant who may be appointed for the purpose by the board of Trustees and the audited statement of accounts together with Auditors' report shall be laid before the Board of Trustees for approval.

16. BANK ACCOUNT:

The Managing Trustee along with the any one of the Trustee shall operate bank account(s) jointly.

17. APPLICATION OF INCOME AND TRUST FUND:

The Board of Trustees shall be empowered to invest the funds of the Trust in movable or immovable properties, in such manner as they deem fit for the purpose of the objects of the trust provided that such investments shall be in accordance with the provision of Section 13(1) read with Section 11(5) of the Income Tax Act, 1961 as well as of any other law for the time being in force as are applicable to charitable trusts.
